This pocket book is an English reprint edition that features all five volumes of the 1862 French historical fiction classic, *Les Misérables*, by Victor Hugo. Published as part of the popular Illustrated Classics Series (#142), the book includes several illustration plates by A.A. Dixon. The book is currently in poor condition with damages most likely due to poor quality materials, handling, and storage.

Detailed Descriptions of Select Conditions

Detached Covers (see Figure 5)	 Location: Upper and lower covers Extent of Condition: For the upper cover, the imitation leather, paper board, and front paste-down are detached at the hinge from the text block. For the lower cover, the imitation leather, paper board, endpapers, and last two pages of the last signature are detached at the hinge from the rest of the text block. The detached edges of the imitation leather are flaking and have some discolouration (fading). Evidence of Past Attempted Treatment: There is evidence of past attempted treatment of the upper cover. There are remnants of one piece of pressure-sensitive tape (2.5 cm (H) x 1.5 cm (W)) partially adhered to the tail of the gutter of the front free endpaper. On the corresponding tail of the gutter of the front paste-down, there is evidence of tape removal (lifted fibers). Impact on Function: The last two pages of the text block are detached with the lower cover, splitting the catalog of additional titles in the Illustrated Classics series into two.
Chipping (?) (see Figure 6)	 Location: Head and tail of spine Extent of Condition: At the head of the spine, there is significant uneven chipping of the imitation leather (0.8 to 1.9 cm inward). This chipping includes the loss of the first word of the title ("LES") and the flaking of the second word ("MISÉRABLES") to the point of being illegible. At the tail of the spine, the chipping is more even (0.8 to 1 cm). This chipping has led to the exposure of the ends of signatures and the binding adhesive at both the head and tail. Impact on Function: With the loss and illegibility of the title, the spine no longer serves the function of identifying the book when in a shelved position. The book must not only be removed from the shelf, but also be opened to reveal its title, as there is no other indication of title on the cover.
Broken Spine (see Figure 7)	 Location: Between signatures (most visibly between pages 98-99, 126-127, 226-227, 256-257, 418-419, 446-447, 702-703) Extent of Condition: All pages are still attached (apart from those detached with the lower cover). Many signatures are loose and out of alignment. The tight back binding is exposed at the hinge between signatures, this includes the sewing thread. There is creasing and cracking (?) along the imitation leather of the spine from these breaks. The book lays open flat at these breaks. Impact on Function: The pages of the text block do not turn with consistency as the book opens and stops at these breaks between signatures.




Figure 2 The book is constructed of 28 signatures that are sewn, case bound, and adhered to the cover using glue at the spine (tight back).




Figure 3 The signatures are made of thin, lightweight, machine-made paper that is translucent. Note the clear typeface in black printer's ink. This image is taken using transmitted lighting.




Figure 5 The detached upper and lower covers. The last two pages of the catalog featuring additional series titles are also detached with the lower cover. Note the evidence of previous attempted treatment of the upper cover with pressure-sensitive tape.




Figure 6 The chipped tail and head of the spine. Note the flaking and loss of the false gilded titling at the head making it illegible, and the exposed signatures.




Figure 7 One of the seven locations that the spine is broken. Here the sewing thread (count 6 perforations) and tight back binding is exposed. The book also lays open flat.
